

NOTICE OF NON-JUDICIAL CONTRACT OFFER IN THE FORM OF AN AFFIDAVIT

Filed, Recorded, publicly posted and becomes Public law in 30 days from filing

**Equality under the law is paramount and mandatory.
Notice to agent is notice to principal, notice to principal is notice to agent.**

**THIS IS NOTICE OF OFFER IN COMMERCE,
EXHAUSTION OF ADMINISTRATIVE REMEDY, and
NOTICE BY ACCEPTANCE of NON-DISPUTABLE AGREEMENT.**

FULL DISCLOSURE STATEMENT: Statutes, codes, rules, regulations, and policies are for fictions and not the living, this is notice of a non-judicial commercial contract offer. The living woman Migna-Yvette: family of Delgado (herein after Migna-Yvette:Delgado) has publicly declared by filed sworn affidavit that she is not a corporation or fiction and does not consent to come under any fiction or corporate restrictions. Migna-Yvette: Delgado does not consent to being represented (re-presented) or that anyone make any legal determination for MIGNA YVETTE DELGADO©™ or any deviation thereof (herein after MYD©™).

All parties who enter this contract enter having full disclosure and under his or her private full commercial liability. All parties who accept this contract accept all the terms and conditions *as stated* herein and forever waive any and all right to alter or in any manner modify herein stated terms or conditions, and do further waive all benefit of discussion or dispute regarding stated terms and conditions. The terms and conditions of this agreement are not subject to judicial intervention, anyone attempting to do so accepts all terms and conditions stated herein under their full private commercial liability. Migna-Yvette: Delgado has in the past and does presently declare that she is competent to handle her own commercial affairs and that all others are incompetent to involve themselves into said affairs absent the wet blue ink autograph of Migna-Yvette: Delgado evidencing appointment as fiduciary as representative for MYD©™.

I, Migna-Yvette: Delgado, a living woman am not the fiction MYD©™, and not the surety for the fiction MYD©™ and I do not consent to any process in any so-called court or hearing wherever found for any charge whatever. Any party attempting to coerce Migna-Yvette: Delgado; MYD©™ by summons, warrant, letter, or by personal appearance becomes an accepting party to the terms of this offer including but not limit to Clerk of Court; Judges; Sheriff; attorneys; and any of their assigns.

Demand is herein made that any charges brought against Me the living woman or MYD©™, served or not served, be dismissed without prejudice. If not immediately dismissed demand is made for a clear concise statement as to whether:

1) Migna-Yvette: Delgado is property of the State; 2) whether it is the *fiction* or the *living woman* the charges are against; 3) by what authority do you appear before Me, put your delegated authority before My court now or get out of My affairs; 4) prove up your claim; 5) produce any and all bond numbers and copies of the bonds relating to the charge; 6) supply all BAR numbers and copies of those British Accredited Regency foreign agents papers for every party involved, and; 7) a copy of the required

1099OID tax form for the presumed case, and; 8) statement as to whether the alleged charge has been sold or otherwise bundled for monetization; and 9) to whom, when, and the bond(s) value.

Terms of offer - legal determination: No one is to make a legal determination in any of the commercial affairs of MYD[©]™ or Migna-Yvette: Delgado. There is imposed a 300 million United States Dollar fine for each determination.

Further, a warrant will be issued for the arrest of such parties bond, and the party shall then be required to perform under the indemnity bond of The Living Woman Migna-Yvette: Delgado. Failure to comply with 'Equality under the law is paramount and mandatory' shall impose a fine of 300 million for each violation.

Terms of offer - copyright: Each violation of My copyright\™ a 300 million United States Dollar fine for per each use.

Terms of offer - detention or jailing: Should there on any occasion hand-cuffs or leg-irons be placed on the living woman Migna-Yvette: Delgado even temporary there is a 300 million United States Dollar fine, agreed to by placing the cuffs or irons. A separate 300 million United States Dollars is applicable to each to the officer(s) superior(s), and agents Principal, Mayor and County Constables, Sheriff and deputies. All parties agree by their act(s) or acts of their agents to be fined, billed and liened, and to other remedies available to Migna-Yvette: Delgado.

Terms of offer - severally and singularly: Should the living woman Migna-Yvette: Delgado be detained in any manner in or out of jail the agent and principal each separately agree to being fined, billed, and liened by Migna-Yvette: family of Delgado in the amount of 300 million United States Dollars *per hour or part thereof* that Migna-Yvette: Delgado is detained or kidnapped.

Terms of offer - Jail or detention conditions: Should Migna-Yvette: Delgado the living woman be held in detention or lockup for any reason she shall at all times be supplied with a chair or bed when requested without delay. Should Migna-Yvette: Delgado be deprived of sleep by surrounding sounds or any noises the living woman declares is harming her, or deprived of the creature comforts of three new heavy duty top quality blankets, two new pillows, a satisfactory mattress pad, any and every drink or food as demanded at anytime of the day or night there will be an additional 300 million United States Dollars per item denial. Should the holding area be below 72 degrees, or above 80 degrees, the determination of whether the stated comfort zone is correct is at the full discretion of Migna-Yvette: Delgado and none other, there is a fine of an additional 300 million United States Dollars per hour, or part thereof such items are denied.

Terms of offer - private possessions: Migna-Yvette: Delgado if detained or jailed shall keep at all time all items of her clothing in her possession at the time of being detained\kidnapped

Should any interloper or attorney attempt to intervene they by that act agree to and assume full commercial liability for the full amount of the claim they attempt to intervene for. This *Notice of Non-judicial Contract Offer in the Form of an Affidavit* is adequate notice of commercial contract presentment.

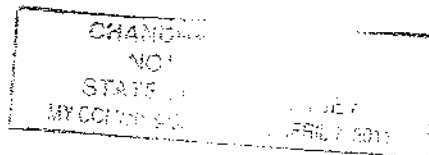
