NOTICE AND JUDGMENT OF DEFAULT

Regarding General Revenue Corporation account # 31143873, the following statements are true.

On July 5, 2007 a Sight Draft MT1146-46 for \$17,357.78, the amount stated in the ORDER OF WITHHOLDING FROM EARNINGS was sent to Judge Michael W. Owen on behalf of General Revenue Corporation at the address listed above via certified mail # 7006 0100 0006 3262 5581 to pay off the above referenced account.

Judge Michael W. Owen received the sight draft on July 10, 2007. General Revenue Corporation had 10 days to present it for payment but has failed or refused to do so

U.C.C. §3-603 Tender of payment.

(a) If tender of payment of an obligation to pay an instrument is made to a person entitled to enforce the instrument, the effect of tender is governed by principles of law applicable to tender of payment under a simple contract.

Further, the United States Supreme Court has ruled:

"His tender, as we have already seen, was equivalent to payment, so far as concerns the legality of all subsequent steps by the collector to enforce payment by distraint of his property." *Poindexter v. Greenhow*, 114 U.S. 270 quoted in *AYERS, SCOTT, MCCABE*, 8 S. Ct. 164, 123 U.S. 443 (U.S. 12/05/1887)

Further:

"Silence can only be equated with fraud when there is a legal or moral duty to speak, or when an inquiry left unanswered would be intentionally misleading... We cannot condone this shocking conduct. If that is the case we hope our message is clear. This sort of deception will not be tolerated and if this is routine it should be corrected immediately"  
*U.S. v. Tweel*, 550 F2d 297, 299-300

Based on the foregoing evidence General Revenue Corporation are hereby deemed to be in default.

DECISION

Decision in favor of LAWRENCE D FEHRENBACHER is hereby granted and it is hereby ordered that:

It is ordered that the agreement involving the above mentioned account has been lawfully surrendered and is void:

Pursuant to U.C.C. § 3-603 (a) the General Revenue Corporation's failure to present tendered Sight Draft is a breach of contract:

It is hereby ordered that General Revenue Corporation shall report the instant account to all credit bureaus as "paid as agreed" and show the balanced owed as zero (0):

It is hereby ordered that General Revenue Corporation will discontinue all collection efforts and harassment of

LAWRENCE D FEHRENBACHER regarding the instant account:


It is hereby ordered that General Revenue Corporation release The Cleveland Christian Home, the employer of Lawrence D. Fehrenbacher from any further liability regarding this instant account. As stated in the ORDER OF WITHHOLDING FROM EARNINGS "...once a debtor's loan(s) is paid in full, the Order will be released".

General Revenue Corporation has refused or is unable to provide proof of debt. This refusal or inability is prima facie evidence that General Revenue Corporation used undersigned's property to fund the instant account. General Revenue Corporation has failed or refuses to return undersigned's property as required. Therefore, it is ordered that General Revenue Corporation pay undersigned in the amount shown on the attached invoice for every month of unauthorized use of undersigned's property.

Failure to comply with this decision will result in the undersigned taking any and all action necessary under natural law to protect their rights, life, and property.

I, Lawrence D. Fehrenbacher, knowing the penalty of bearing false witness, hereby affirm, under penalty of perjury, the foregoing to be true and correct to the best of my knowledge and belief and do affix my signature in testimony of the foregoing default judgment.


