NOTICE OF JUDGMENT AND DEFAULT

Regarding:

Tax Year: December 31, 2003
Tax Form: 1040A

the following statements are true:

On March 28, 2006 a Check was sent to Internal Revenue Service to pay off the alleged tax shown on the above referenced notice in the amount \$3,309.30. The Internal Revenue Service had 10 days to present it but has failed to do so.

U.C.C. §3-603 Tender of payment.

(a) If tender of payment of an obligation to pay an instrument is made to a person entitled to enforce the instrument, the effect of tender is governed by principles of law applicable to tender of payment under a simple contract.

Further, the United States Supreme Court has ruled:

"His tender, as we have already seen, was equivalent to payment, so far as concerns the legality of all subsequent steps by the collector to enforce payment by distraint of his property." *Poindexter v. Greenhow*, 114 U.S. 270 quoted in *AYERS. SCOTT. MCCABE.*, 8 S. Ct. 164, 123 U.S. 443 (U.S. 12/05/1887)

Further:

"Silence can only be equated with fraud when there is a legal or moral duty to speak, or when an inquiry left unanswered would be intentionally misleading... We cannot condone this shocking conduct... If that is the case we hope our message is clear. This sort of deception will not be tolerated and if this is routine it should be corrected immediately."
U.S. v. Tweel, 550 F2d 297, 299-300.

Based on the foregoing evidence Internal Revenue Service is hereby deemed to be in default.

DECISION

Decision in favor of CYNTHIA P BULLOCK is hereby granted and it is hereby ordered that:

Pursuant to U.C.C. § 3-603 (b) the Internal Revenue Service has breach its contract;

Internal Revenue Service will discontinue all collection efforts and harassment of CYNTHIA P BULLOCK regarding the tax year 2003;


The refusal or inability of the Internal Revenue Service to provide a lawful assessment is prima facie evidence that CYNTHIA P BULLOCK has no tax liability for the tax year 2003;

Internal Revenue Service will return all monies received for CYNTHIA P BULLOCK and held on deposit by Internal Revenue Service for the tax year 2003 with interest and penalties according to the attached statement;

Failure of the Internal Revenue Service and its employees to comply with this decision will be construed as treason pursuant to Article III, Section 3, of the Constitution for the United States of America.

I, Cynthia P. Bullock, knowing the penalty of bearing false witness, hereby affirm, under penalty of perjury, the foregoing to be true and correct to the best of my knowledge and belief and do affix my signature in testimony of the foregoing default judgment.


