RE: Delinquent tax assessed on the resident name of: PENNY VASQUEZ

Dear Sir –

I am Penny Vasques's 'next friend' only not a guardian ad idem, or officer of this court, but have been authorized via POA to deal with the priority unpaid tax assessed against her resident, registered name of PENNY VASQUEZ.

Penny's awareness level is not to a high enough degree yet to know how this international court of fiction with its deadman statutes as bonds measured in dollars of international units in the context of 'Trust Law' functions. 


